## Section 2. Hazards Identification

### Emergency overview

### Acute Effects

#### Routes of Entry

Dermal contact. Eye contact. Inhalation.

**Eyes Skin** Corrosive to eyes. Causes burns. Direct contact with the eyes can cause irreversible damage, including blindness. Inflammation of the eye is characterized by redness, watering and itching.

**Inhalation** Corrosive to the skin. Causes burns. Skin inflammation is characterized by itching, scaling, reddening or, occasionally, blistering.

Corrosive to the respiratory system. Exposure to decomposition products may cause a health hazard. Serious effects may be delayed following exposure. May cause irritation of respiratory tract, coughing, shortness of breath.

**Ingestion** Harmful if swallowed. May cause burns to mouth, throat and stomach.

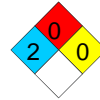

**Section 4. First Aid Measures**

<b>Eye Contact</b>	Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.
